I acknowledge and agree that the K.U.A Qld shall not be liable whether in tort or contract or otherwise for any loss or damage whatsoever to my property whilst participating in or otherwise attending at the tournament, howsoever caused or occurring including without limiting the foregoing, the negligence, breach of contract, willful act or default of the K.U.A and whether or not such loss or damage to my property occurs within or adjacent to any property occupied by the K.U.A Qld.
